- \_\_\_\_\_ **Hand Appliqued Quilt.** Any size. Must be at least 50% appliqued.
- \_\_\_\_\_ **Machine Appliqued Quilt.** Any size. Must be at least 50% appliqued
- \_\_\_\_\_ **Appliqued and Pieced Quilt.** Any size. Machine quilted by self.
- \_\_\_\_\_ **Appliqued and Pieced Quilt.** Any size. Machine quilted by other.
- \_\_\_\_\_ **Panel Quilt.** Any size, type of technique or quilting for a quilt in which any or all parts of a preprinted panel has been incorporated.
- \_\_\_\_\_ **Modern Quilt.** Any size. Quilted by self or professionally. Modern quilt characteristics include a minimalist style with emphasis on negative space and generally feature asymmetry, bold colors, graphic design and alternate grid work.
- \_\_\_\_\_ **Youth Quilt.** Exhibitor/Creator must be under the age 18. Any size, technique, combination of techniques and quilting. Non-member entry fee is waived.
- \_\_\_\_\_ **Art Quilt – Original Design.** Any size, technique or combination of techniques. Quilted by self. The design may be either abstract or pictorial. Includes whole cloth quilting
- \_\_\_\_\_ **Art Quilt – Commercial Design.** Any size, technique or combination of techniques.
- \_\_\_\_\_ **Group Quilt.** More than 2 people involved in quilt top completion. Any size, any technique, or quilting techniques.
